**AMENDMENT TO ARTICLES OF INCORPORATION OF  
LEGACY RIDGE HOMEOWNERS ASSOCIATION, INC.**

The following is an amendment to the Articles of Incorporation of the Legacy Ridge Homeowners Association, Inc., originally recorded as an Exhibit to the Declaration of Covenants, Conditions and Restrictions of Legacy Ridge at Official Records Book 25189, Page 41, et. seq., of the Public Records of Hillsborough County, Florida, and as amended.

New Wording Underlined; Deleted Wording ~~Stricken Through~~ (Except when proposed amendment involves substantial rewording):

---

**Article VII, Section 1 of the Articles of Incorporation is amended to read as follows:**

Section 1. The Association's affairs are managed by a Board of Directors initially composed of three Directors. The initial Directors named below shall serve until this Association's first annual meeting. The term of office for all Directors is ~~one year~~ as stated in the Bylaws. Before any such annual meeting, all vacancies occurring on the Board of Directors, if any, will be filled by majority vote of the remaining Directors, even if less than a quorum. Any Director may succeed himself or herself in office. All Directors will be elected by ballot. Each member may cast as many votes for each vacancy as such member has; and the person receiving the largest number of votes cast for each vacancy is elected. Cumulative voting is not permitted. Directors ~~need not~~ must be Association members.

END OF AMENDMENT
